



**Davis Legacy Soccer Club
2019-20 Player/Family Participation and
Membership Agreement for Volunteer and Financial Obligations**

Accepting a position as a player on a team involves a commitment of both time and money for the family. It is required that the player and their family will participate for the entire season, abide by our sportsmanship requirements, and meet the volunteer and financial obligations as outlined below.

Sportsmanship

Both our club and league (NorCal Premier) understand and value the importance of good sportsmanship. The end result is players who understand the value(s) of civility and respect for others in their relationships both on and off the soccer field. Parents must be helped to develop a “long term” view of our wonderful sport that places more emphasis on the development of more skillful players and teams than the winning of games. Coaches and players should show maximum respect for the game by always respecting the opposition, the referees and each other. Parents will also be required to exhibit the same respect for the game by only showing positive support for the team. Any behavior outside the bounds of positive encouragement will warrant a club sanction.

Volunteer Obligations

During the year, our club hosts a number of club-hosted tournaments. The hosting of tournaments provides a major source of revenue for the club’s operation, which directly affects the level club dues are set at each year.

Therefore, in order to maximize our return from each tournament, each family is required to provide a minimum of eight (8) hours per registered player of volunteer work at a club-hosted tournament. During a tournament weekend, all parents of the assigned team can expect to be at the fields for most of the day, as well as helping with pre-tournament assignments during the week(s) prior to the tournament. Each team will be notified at least 30 days in advance regarding which tournament families on their team will be needed to provide volunteer services.

In lieu of providing eight (8) hours per registered player of volunteer work at a club-hosted tournament, a family may opt out of their “Volunteer Obligation” (i.e. time commitment) by paying a one-time \$150 fee per registered player. If you do not opt out, and you fail to comply with your Volunteer Obligation, you will be subject to a club sanction.

Commitment to Team

Forming a team takes significant amount of time and effort for club administrators and the coaching staff. Each family who receives and accepts a position on a club team is expected to participate on that team for the full-prescribed program length. Any family who receives and accepts a position on a team at any point after the start of the season is expected to participate on that team for the remainder of the prescribed season. The only exceptions to this requirement are for any player who is selected to participate in an approved USSF Academy team (Boys or Girls) at the U15 and up age groups or any player who is no longer in high school and will be attending college following the end of summer. In both those cases partial participation and commitment is allowed.

Financial Obligations

Each family who has a player participating on the team is required to pay the club dues, as outlined in Appendix A and described below. The dues cover club costs associated with coaching, member clinics (striker/skills/keeper), NorCal league registration fees (every team participates in two league seasons), team tournament entrance fees, NorCal State Cup entrance fees, coach travel reimbursements, US Club registration, field and facility maintenance, player insurance, and referees. The club dues do not include the cost of uniforms, individual equipment, individual costs associated with traveling to a tournament or match. Unless otherwise specified, club dues are set at a level to be as close to all-inclusive as possible. However, there could be other discretionary team related costs that may materialize, which are not accounted for in the club dues and for which you would be responsible for your fair share of the expense. For ECNL Teams there are also mandatory travel fees that are separate and apart from your club dues that each player is required to pay. You can visit the club's ECNL webpage for more information regarding the ECNL travel fees.

Club dues are similar to tuition. They are not optional. If you are unable to attend a tournament or train for any reason including illness or injuries, no refund is due. Refunds are also not provided in the case of field closures due to weather related closures or dangerous playing surface conditions. Players who suffer serious injuries lasting more than two months, however, may submit a request to the Davis Legacy Soccer Club seeking a waiver in Club Dues pursuant to the Club's Injured Player Policy. The club does provide financial aid, ranging from \$300-\$900 for families in financial need. The financial aid does not cover a full season cost of club dues. Interested families will be asked to fill out a brief application to confirm financial need and provide required supporting documentation. Individual teams, at their discretion, may provide additional assistance to financial aid families by fundraising throughout the year with the proceeds from the fundraiser being directed to the financial aid families. Each family must be aware of the need to make all required payments in a timely manner. All dues are due by the 15th of each month and must be submitted according to the following monthly payment schedule (please note the payment schedule does not correlate to the teams operating schedule):

- U9-U19 Teams: June 2019 through March 2020 (10 Monthly Payments beginning June 15 2019 and ending March 15 2020)

For U9 to U15 teams, the club dues must be paid via electronic check or credit card. For U16 and older teams, club dues may be paid via cash, check, electronic check, or credit card. Checks should be made out to "DYSL" and can be dropped off at the payment drop box at the fields or mailed to the following address:

When mailing or dropping off your payment you must include the name of your player on the memo line of the check. Credit card payments are preferred and can be made via your player's GotSoccer account or by requesting a credit card payment from the club treasurer.

Nothing prohibits a family from paying the full amount, or more than the regular scheduled monthly payment in advance.

Payments delinquent more than sixty days after the due date will be cause for player suspension from practices and games until the account has been brought current. If a family is unable to meet the payment schedule due to temporary circumstances, please contact the Club Administrator, to establish a payment plan to accommodate the circumstance. If a family does not meet its financial obligations for the season, then notification will be made to the coaching staff and participation in any club program and tryouts (including with other teams in the club) will be prohibited until the financial obligation has been met. No Exceptions.

The undersigned family agrees to meet the monthly payment schedule for the entire season, even if we choose to leave early. If circumstances require the family to leave the team prior to the end of the team's season, the family may petition the Club Administrator for a waiver from some portion of the remaining cost. However, there is no guarantee a waiver of the remaining cost will be provided. Waivers are granted at the sole discretion of the Davis Legacy Soccer Club.

Program Notes and Requirements

¹ Club dues are all inclusive, **unless otherwise noted**, and specifically helps the club cover all club costs associated with coaching expenses, club member training clinics, keeper training, field maintenance costs, Insurance, US Club registrations, referee expenses, tournament registration expenses, league registration expenses, coach travel reimbursements, and administration.

² Teams/Members will/may incur other costs that are specific to their individual team, or the individual member, and are not covered by Club Dues. They could/will include: Uniforms, Training Shirts, Team Equipment, personal cost of travel, and other team specific discretionary costs, team field rentals, etc. ECNL players will also incur additional mandatory travel fees as required for participation in that program. ECNL Team's must travel together for all ECNL away events.

³ All 11 to 02/01 Teams may participate in up to two league seasons (Fall 2018 and Spring 2019), **no exceptions**. ECNL only participates in its respective league. ECNL may participate in NPL if the club Executive and Technical Directors decides its in the best interest of team development.

⁴ All 05 to 02/01 teams must take the high school soccer season off, **no exceptions**. This is the club scheduled winter break for these teams.

⁵ 11 to 06 Red/White/Black Teams may participate in no more than 6 tournaments (for 08, 07 and 06 ECNL and Pre-ECNL Teams ECNL Showcases Count as Tournaments). 05 to 02/01 Red/White/Black Teams may participate in no more than 6 tournaments (for 05 to 02/01 ECNL Teams ECNL Showcases Count as Tournaments). Exceptions to these requirements will be allowed only for Teams that advance to National level competitions by winning league or other events. 11 to 08 Red/White/Black may not participate in out of state (CAN) tournaments. 07 to 02/01 White/Black teams may not participate in more than 2 out of state (CAN) tournaments. Furthermore, the number of tournaments listed is not a requirement, rather, it is a cap. Teams can, and some will, do less than the cap. The club will be prescribing the majority of tournaments for all teams. For any tournament not prescribed by the club, the decision on the tournament(s) the team will attend is left to the coach to decide, however, the coach decision is subject to the approval of the Executive Director of Coaching and/or the Technical Director of Coaching **and** the Club Administrator.

⁶ Most teams, except ECNL teams, participate in state cup.

⁷ 12/13 Developmental Teams Register and Pay for two separate and distinct seasons. The first season and associated payments, is March 2019, April 2019, and May 2019. The second season, and associated payments, is August 2019, September 2019, October 2019, and November 2019.

⁸ All Teams Pay June 2019 through March 2020 (10 Months). The Season is 12 Months (June 2019 through May 2020), of which 9 or 10 months, depending on the team, are active and between 8 and 12 weeks of down time, depending on the team is required to be taken off. Generally the off time is taken during the high school or winter season for most teams. Fees are not waived if you leave the club of your own volition prior to the end of the season.

⁹ 05 to 02/01 Red/White/Black Team players who are not participating in high school soccer during the winter break can participate in free club training sessions that will be offered by the club during this time period. The Club will also consider a combo team(s) for participation in NorCal winter league if sufficient numbers are available to play.

¹⁰ Soccer is an outdoor activity that can be impacted by inclement weather. Heavy rains can and do close the fields. There are no refunds if games or trainings are canceled as a result of inclement weather, including rain.

¹¹ Under no circumstances does the Club provide refunds to members as the result of events outside of our control. This includes but is not limited to natural disasters, emergency government actions, etc...
