- C. <u>Executive Director of Coaching Update/Technical Director of Coaching Update (David)</u>:
  - Tryout dates are set and numbers are significant.
  - Return to Play Leagues are progressing and there are no major incidents or concerns.
  - We will be adding 6 new coaches to the staff for next season and 4 existing staff will be transitioning out. Details will be released soon.
  - ECNL is having an abbreviated
- D. <u>DLSC/City Fields/COVID Coordinator Update (Mark)</u>: COVID efforts have been a team effort with Justyn to keep Club 'up and running' during COVID.
  - Summer Bulk request has been sent to the city for approval.
  - We continue to get questions related to COVID and vaccine. All questions are being addressed timely.
- E. <u>Treasurer Report (Phil)</u>: None.
- F. Financial, Membership, Tournament, and Administration Update (Justyn):
  - We entered into an MOU with the County to use the complex for a mass vaccine site.
  - Summer Camp registrations are currently at 61. We are on track to meet or exceed the 2019 numbers.
  - Spring Grassroots program ended with 104 participants.
  - As of April: ~\$700,000 cash on hand. There will be no dues collected for May and June.
  - Quarter 1 we were ~\$11K to the good.
  - The club is transitioning the registration system into GotSport.
  - The club is switching from College Fit Finder to ScoutingZone. Switch starts June 1.
  - 2020 Taxes are due by May 15<sup>th</sup>. Will seek and extension to November.
  - We ae starting our annual Workers Comp Audit through SCIF.
  - The Healthy Davis Together fundraiser and testing program is working well. April is last month to earn money for the club.
  - The UPSL Men's team starts this month.
  - Currently evaluating multiple companies for video services for tournaments and/or ECNL home matches.
  - We are looking to revamp our social media presence and are working on a comprehensive brand guide for the club.

- Coach employment contracts are being drafted and will be in place by the end of May.
- Governor announced June 15 is the full reopening date for the state.
- NorCal College Showcase to take place on June 19/20.
- US Club will decide whether to proceed with their June 12-15 event by the beginning of May.
- Proposed U9 to U14 Legacy event on Jun 16/17.
- We ordered a few new 7v7, 9v9, and 11v11 goals.
- We are getting bids to replace the frontage road sign with a new monument sign. Replacement is required under our lease agreement.
- We are making adjustments to our website including adding a sponsorship and partners' page.
- Board elections will take place in July. Nominees are due by mid-July. 3 officer positions are up as are all team rep positions.
