#### 7. OFFICER AND COACHING UPDATES:

- A. President Update (Josh): None.
- B. Referee Update (Justyn): Clinic scheduled on January 8 with one additional planned every quarter. Still struggling with short numbers with potential for no referee for league games. Had to reduce older games down to one referee. Goal to contribute to referee pool and advantage to have local referees as they are more likely to be allocated to us. David advised that to his knowledge we are the only Club in area to not have to cancel games.

Rob: what is the minimum age.

Jeff: team manager may need to take lead to walk parents that are warned to parking lot.

David: coach gets suspended for parent behavior (regardless of knowledge). Vicious circle because pool is less experienced which results in more issues.

#### C. Executive Director of Coaching Update (David):

- Good of the Game:
- <u>U9/U12 Technical Director</u>: Brian Siefert is the technical lead for US Club Soccer for West Coast
- Gordon Young: Technical consultant will be meeting with Club periodically; January 8 presentation ... advising Robo, Simon and Jesus
- Individual meetings with all 40 coaches in January to elicit feedback, etc.
- Drop-ins have started. Some preliminary weather cancelations with olders but tomorrow on Playfields
- Parents on fields is starting to become a problem; must be outside and not walking across fields.
- Teams playing indoor during break but cannot do so as a representative of Davis Legacy.

#### D. <u>DLSC/City Fields Update (Justyn)</u>:

- 1. Field Updates (Justyn):
- Fields closed due rain. Only two games left for season (one Storm and one reschedule).
- Tony is shoring up fields (note large piles of dirt).
- Stocking up on supplies to take advantage of bulk purchases before vendor noticed price increases in the new year.
- Will be looking at play rotations in new year to spread out wear and tear on fields.
- Working with City of Davis and Davis AYSO to address bulk field request conflicts.

- E. <u>Treasurer Report (James)</u>: \$450k funds primarily in reserves (short of the historical \$550,000 reserves); anticipate year end of ~\$425,000. On the front end of annual audit process that will run through first few months of the new year.
- F. <u>Membership Update (Justyn)</u>: We are losing some players U9 through U19; not unusual especially for older boys.
