

Davis Legacy Soccer Club 2022-23 Player & Family Participation and Membership Agreement for Sportsmanship and Good Behavior, Team Commitment, Volunteer and Financial Obligations

Accepting a position as a player on a team involves a commitment of both time and money for the family. It is required that the player and their family will commit to participate on the team for the entire season, abide by our sportsmanship and good behavior requirements, and meet the volunteer and financial obligations as outlined.

Sportsmanship and Good Behavior

Both our club and leagues (NorCal Premier, Elite Club's National League, National Premier League, and US Club Soccer) understand and value the importance of good sportsmanship and ethical behavior. The end result are players who understand the value of civility and respect for others in their relationships both on and off the soccer field. Parents must develop a "long-term" view of our wonderful sport that places more emphasis on the development of more skillful players and teams than the winning of games. Coaches and players shall show maximum respect for the game at all times by always respecting the opposition, the referees and each other. Parents are also required to exhibit the same respect for the game at all times by only showing positive support for the team. Any behavior outside the bounds of positive encouragement will warrant a club sanction, including but not limited to, suspension(s) or expulsion from attending games or from the club.

Parents shall also show respect at all times to club employees and officials. Any and all types of threats towards club staff or officials, whether veiled or explicit, written or oral, implied or expressed, and any type of slander, defamation, false accusation, or other disparaging comment about Davis Legacy Soccer Club or its staff and officials shall be grounds for immediate dismissal from the club. Being unhappy about your player's team placement, playing time or the direction of the team is no excuse for poor sportsmanship and bad behavior.

Finally, at no time shall a parent or player publicly criticize, disparage, call into disrepute or otherwise defame or slander the club, including any current employee, contractor, official or officer, in any manner that would reasonably be expected to damage the business, reputation, or services of the club, or our officers, directors, employees, or other representatives. Any such actions shall be grounds for immediate dismissal from the club.

Anyone dismissed from the club due to poor sportsmanship or bad behavior shall no longer be considered in "good standing" and shall be ineligible from participating in any future club activities, including future tryouts and camps.

Volunteer Obligations

During the 2022-23 season, our club will host six (6) Davis Legacy Tournaments. The hosting of tournaments provides a major source of revenue for the club's operation, which directly affects the level club dues are set at each year.

Therefore, in order to maximize our return from each tournament, each family is required to provide approximately six (6) to eight (8) hours (two work shifts in total), per registered player of volunteer work at one of our six (6) club-hosted tournaments. During a tournament weekend, all parents of the assigned team can expect to be at the fields for a good portion of the day, as well as helping with pretournament assignments during the week(s) prior to the scheduled tournament. If a family is unable to volunteer at their team's assigned tournament, you may request to be rescheduled to volunteer at a future tournament, assuming there is a need for additional volunteer help at a future tournament. Rescheduling is done at the sole discretion of Davis Legacy and is not guaranteed.

Families that fulfill their two volunteer shifts, will be eligible to have their \$150 registration fee refunded on or after May 15, 2023. The \$150 registration fee will be refunded only if the family fulfills their Volunteer Obligations, as outlined in this section, <u>AND</u> fulfills their Team Commitment, as outlined in the next section.

Team Commitment

Forming a team takes a significant amount of time and effort by club administrative and coaching staff. Forming a team also results in a substantial commitment of funding from the Davis Legacy Soccer Club to operate that team for a full season. As such, each family who receives an offer to join and accepts a position on a club team is expected to participate on that team for the full-prescribed program length. Any family who receives an offer to join and accepts a position on a team at any point after the start of the season is expected to participate on that team for the remainder of the prescribed season. The only exceptions to this requirement are for any players who are no longer in high school and will be attending college following the end of summer (U18/U19 teams only). Only in those specific cases will partial participation and team commitment be allowed.

Financial Obligations

Each family who has a player participating on the team is required to pay the Club registration fee and Club dues (membership and uniform fees), as outlined in Appendix A and described below. The Club registration fee and the Club dues help to <u>partially</u> cover various club costs including, but not limited to, coaching (employee) costs, member clinics (striker/skills/keeper), NorCal and ECNL league registration fees, team tournament entrance fees, NorCal State Cup entrance fees, coach travel reimbursements, US Club registration, field and facility maintenance, utilities, player and facility insurance, referee fees, etc. For the 2022-23 season, the club dues also include the cost of your required uniform kit. *Please note that club dues are not set at a level to cover all the costs described above for each team. The cost of operating a team is subsidized from other club revenue sources*.

Additionally, Club dues do not cover costs associated with individual equipment or individual costs associated with traveling to a tournament or league match. There could be other discretionary team related costs that may materialize, which are also not accounted for in the club dues and for which you would be responsible for your fair share of that team expense. For ECNL Teams there are also mandatory travel fees that are separate and apart from your club dues that each player is required to pay in order to participate in that program. You can visit the club's ECNL webpage for more information regarding the ECNL travel fees.

Club dues are similar to tuition. They are not optional. If you are unable to attend a tournament or training session for any reason including illness or injuries, no refund is due. Refunds are also not provided in the case of field closures due to weather including, but not limited to, excessive heat or rain or other dangerous playing conditions that may arise (e.g., poor air quality). Refunds are also not provided due to events outside of the club's control, including but not limited to, earthquakes, floods, fire, pandemics, etc.

Notwithstanding the prohibition against providing refunds as described above, if there is a government mandated stoppage of in person trainings sessions the club will examine the length of the government mandated stoppage and where appropriate reduce club dues by one (1) or two (2) months. The club will reduce dues by one (1) monthly payment for every thirty (30) consecutive days that the government enforces a mandatory shut down of on the field activities. The maximum amount of club dues that may be reduced will not exceed two (2) monthly payments. Davis Legacy Soccer Club is solely responsible for determining whether or not a government shut down order is in place and whether the length of the shutdown would trigger a reduction in monthly payments pursuant to this paragraph.

Players who suffer serious injuries lasting more than two months where such injury occurred during an approved Davis Legacy activity may submit a request to the Davis Legacy Soccer Club seeking a waiver of Club dues pursuant to the Club's Injured Player Relief Policy. The Club's Injured Player Relief Policy and procedures for submitting a request can be found on the club's website at: Injured Player Relief Program

The club does provide financial aid, ranging from \$600-\$1,200 for families in financial need. The financial aid does not cover a full season of club dues. Interested families will be asked to fill out a brief application to confirm financial need and provide supporting documentation. Individual teams, at their discretion, may provide additional assistance to financial aid families by fundraising throughout the year with the proceeds from the fundraiser being directed to the financial aid families on the team. Each family must be aware of the need to make all required payments in a timely manner. The \$150 registration fee is due immediately upon program registration. All Club dues are payable by the 15th of each month and must be submitted according to the following monthly payment schedule (*please note the payment schedule has zero correlation to the team's operating schedule and the club reserves the right to change the program requirements/structure at any time*):

• U9-U19 Teams: July 2022 through April 2023 (10 Monthly Payments beginning July 15, 2022 and ending April 15, 2023).

For the 2022-23 season, <u>ALL</u> club members must pay for their uniform kit through the Club as part of their Club dues. Families will be given the following two options to pay for their player's uniform kit:

- A one-time payment submitted along with their first monthly payment in July 2022; or
- 6 monthly payments submitted along with each of their first six monthly Club dues payments (July 2022 through December 2023).

All club dues must be paid via credit card. The club will no longer accept payments via check, unless a member can demonstrate a compelling financial need to continue paying by check. Accepting payments by check is at the sole discretion of the Davis Legacy Soccer Club.

Nothing prohibits a family from paying the full amount, or more than the regular scheduled monthly payment in advance. A family may request to make an advanced payment(s) by contacting the club Director of Administration and Finance at: jhoward@davislegacysoccer.org

Monthly payments delinquent more than sixty days after the due date will be cause for player suspension from practices, games, and any other club activities until the account has been brought current. If a family is unable to meet the payment schedule due to temporary circumstances, please contact the club Director of Administration and Finance (email address is above), to establish a revised payment plan to accommodate the circumstance. If a family does not meet its financial obligations for the season, then notification will be made to the coaching staff and participation in any club program and tryouts (including with other teams in the club) will be prohibited until the financial obligation has been met. *No Exceptions*.


The undersigned family agrees to pay the registration fee and fulfill the monthly Club dues payment schedule as outlined above and in Appendix A for the entire 2022-23 season, even if we voluntarily choose to leave the club early. If circumstances require the family to leave the team prior to the end of the team's 2022-23 season, the family may petition the club Director of Administration and Finance for a waiver from some portion of the remaining cost. However, there is no guarantee a waiver of the remaining cost will be provided. Waivers are granted at the sole discretion of the Davis Legacy Soccer Club.



Davis Legacy Soccer Club 2022-23 Season Club Dues

Program Details

¹ Club dues are set at a level to help the club, among other things, cover portions of various costs associated with coaching expenses, club member training clinics, keeper training, field and facility maintenance costs, Insurance, US Club registrations, referee expenses, tournament registration expenses, league registration expenses, coach travel reimbursements, and all other operational costs. ECNL players will also incur specific travel fees, which are not listed above, and are required in order to participate in that program. ECNL Teams must travel together for all ECNL away events when arranged to do so by the club. Club dues are in no way are intended, nor do they actually cover, all club costs associated with all club activities. They only cover a portion of such costs.

² Teams/Members will/may incur other costs that are specific to their individual team, or the individual member, and are not covered by club dues. They could/will include: Team Equipment, personal cost of travel, and other team specific discretionary costs, team field rentals, etc.

³ All 14 to 05/04 Teams may participate in one or two league seasons (Fall 2022 and/or Spring 2023). ECNL Red Teams may only participates in its respective league. ECNL may participate in NPL if the club Executive and Technical Directors decide its in the best interest of team development. There is no guarantee that a team will participate in more than one league season.

⁴ All 08 to 05/04 teams must take the high school soccer season off, no exceptions. This is the club scheduled winter break for these teams.

⁵ All Red/White/Black Teams may participate in no more than 5 tournaments (for all ECNL and Pre-ECNL Teams, ECNL Showcases Count as Tournaments). Exceptions to these requirements may be allowed only for Teams that advance to National level competitions by qualifying through league results.

14 to 11 Red/White/Black Teams may not participate in out of state (CAN) tournaments.

09 to 10 White/Black Teams may only participate in one out of state (CAN) tournament.

09 to 10 Red Teams and 08 to 05/04 White/Black teams may not participate in more than 2 out of state (CAN) tournaments.

08 to 05/04 Red Teams may not participate in more than 3 out of state (CAN) tournaments.

Please note, the number of tournaments listed is not a requirement, rather, it is a cap. Teams can, and some will, do less than the cap, as league games could result in more than enough games for proper team development. The club will be prescribing the majority of tournaments for all teams. For any tournament not prescribed by the club, the decision on the tournament(s) the team will attend is left to the coach to decide, however, the coach decision is subject to the approval of the Executive Director of Coaching and/or the Technical Director of Coaching and the Club Director of Administration and Finance. Participation in tournaments are not guaranteed and refunds are not provided should a team not participate in a tournament.

⁶ All teams, except ECNL teams, which includes ECRL teams when they participate in ECRL league, may participate in state cup.

⁷ All Teams Pay July 2022 through April 2023 (10 Months). The Season is 12 Months (June 2022 through May 2023), of which 9, 10, or 10.5 months, depending on the team, are active and between 8 and 12 weeks of down time, depending on the team is required to be taken off. Generally the off time is taken during the high school or winter season for most teams. Fees are not waived if you leave the club of your own volition prior to the end of the season. Additionally, the monthly dues are not tied to whether or not the team is on break or is actively training.

8 08 to 05/04 Red/White/Black Team players who are not participating in high school soccer during the winter break may participate in free club training sessions that will be offered by the club during this time period.

⁹ Soccer is an outdoor activity that can be impacted by inclement weather. Heavy rains can and do close the fields. There are no refunds if games or trainings are canceled as a result of inclement weather, including rain. Closure of the fields is done so at the sole discretion of the club.

¹⁰ Under no circumstances does the Club provide refunds to members as the result of events outside of our control. This includes but is not limited to natural disasters, emergency government actions impacting operations, pandemics, etc...

¹¹ There is a one-time registration fee for the 2022-23 season totaling \$150 that is due immediately upon registration. This amount will be refunded to the payee if the club required volunteer requirements are fullfilled and the registered player participates for the entire 2022-23 season.
