

Davis Legacy Soccer Club 2025-26 Financial Aid Application Criteria & Process

Davis Legacy Soccer Club (DLSC) is making available a total of \$75,000 in financial aid credits for the 2025-26 U9-U18/U19 Competitive Soccer Program, 2025 Fall Recreational Soccer Program, 2026 Spring Recreational Soccer Program, 2025 Fall U6-U8 Development Academy, and the 2026 Spring U6-U8 Development Academy. Financial aid recipients must meet the criteria outlined below and apply following the process described herein. Each Financial aid request, including supporting documentation, will be handled confidentially and shared only with authorized club administrative staff.

Financial Aid Application Process

- Financial Aid applications should be emailed to: <u>jhoward@davislegacysoccer.org</u>. Submit all the following when sending in your information:
 - A completed DLSC Financial Aid Application Form. The application form can be found on the DLSC website: <u>http://davislegacysoccer.org/financial-aid/</u>
 - A copy of your 2023 and 2024 Federal Tax Form 1040 (A copy of your spouse's forms, too if you are filing separately)
- Applications for Financial aid will be accepted on a rolling basis throughout the season until all credits have been depleted.

Financial Aid Policies

- Financial aid is awarded to players based on financial need only.
- To be eligible for Financial Aid, you must commit to participating for the entire competitive Season (June 2025 to May 2026). Anyone electing to leave the program early as a result of their own choice will have their Financial Aid award revoked, and you will be responsible for paying any amounts due as a result of the revocation before being released.
- Financial aid awards are revocable if the applicant fails to meet any other conditions listed in the program requirements.
- For competitive team players, your financial aid award will be credited directly to your BYGA account and evenly spread out over your outstanding monthly payments, thereby reducing your monthly payment but not eliminating it.
- For recreational team and U6-U8 Development Academy players, your financial aid award will be a partial refund of your program registration fee, equal to the amount of your award.
- No financial aid will be granted to returning players who (or players whose siblings) have a delinquent account from prior seasons.
- Financial Aid must be submitted via email. Contact the club Director of Administration and Finance if you are having issues submitting documents electronically to make alternate arrangements.
- Financial aid recipients within the competitive program also have the opportunity to volunteer for parking shifts at DLSC events to reduce their family's financial burden further. \$17 per hour per parking volunteer shift will be credited to your player's account. Please note that the sum of the financial aid and the credits earned by volunteering for DLSC parking shifts may not exceed the club dues for the 2025-26 season. The Parking shift program is only open to families enrolled in the competitive soccer program.
- Information submitted in support of a financial aid application will be kept confidential, except to the extent necessary to administer the program effectively.
- Anyone joining Davis Legacy after July 31, 2025, and who is eligible for Financial Aid will have their Financial Aid award prorated in a manner determined by Davis Legacy.
